KEEPING YOU INFORMED

Welcome to the inaugural annual report from the Pediatric Nursing Certification Board (PNCB)!

This report provides an overview of activities during our last fiscal year (October 1, 2020 to September 30, 2021) including a **new strategic plan, DEI roadmap, and the Continuing Competence Summit**. We have added a new volunteer position to our Institute of Pediatric Nursing (IPN) committee – an Emerging Leader Fellow – and we're supporting the IPN as they develop new priorities to strengthen pediatric nursing for the profession and child health.

As developmental, behavioral, and mental health (DBMH) conditions continue to escalate for children, teens, and young adults, PNCB offered more ways to assist nursing professionals who encounter ongoing and unmet needs for their patients. From 35+ contact hours of targeted **DBMH continuing education** to listening to focus-group feedback about the **Pediatric Primary Care Mental Health Certification (PMHS) program**, PNCB wants to support these youth through first-line providers and those behind the scenes in other roles. To that end, we are highlighting some of our latest CE modules in this report. All nursing professionals can take advantage of these modules.

Many great changes are coming for PMHS, which celebrated its 10th anniversary this year. We will offer the PMHS exam more often and provide webinars and other outreach to help interested advanced practice nurses build confidence as they prepare. A clearer roadmap on PMHS eligibility is being developed, and PMHS Recert will move from every three years to a convenient annual renewal.

Certified Pediatric Nurse (CPN) and Certified Pediatric Nurse Practitioner (CPNP) recertification was also a focus this past year as we presented eight years of research at our Summit on Continuing Competence in September 2021. Our goal is to strengthen evidence-based renewal processes and make Recert more meaningful for certificants and other stakeholders. Thank you to the 12,000 certificants who provided feedback during our research journey. Look for the videos and a CE module soon to learn about the research findings and possible changes.

We are also proud to recognize our many amazing volunteers in this report. There has never been a better time to get more involved with PNCB. To support the new strategic plan, we will need dedicated pediatric nursing professionals with diverse backgrounds and perspectives to help make our goals a reality. After reading this report, please let us know if you are interested in serving in our **volunteer interest survey**.

And finally, PNCB introduced new organizational culture practices to enhance program operations, staff engagement, and the workplace experience. These initiatives included a staff culture assessment, establishment of staff core values and a culture of learning, interactive quarterly all-staff meetings, annual work priorities and success measures, project teams, and more.

PNCB took great strides forward in the face of the ongoing coronavirus pandemic, and we are excited to continue this momentum as we embark on our new strategic plan.

YEAR IN REVIEW

PNCB closed out its 2021 fiscal year by sharing findings from a multi-year research project to answer the following questions and many others: When a certified nursing professional renews their credential, what does that mean for the nurse, the profession, and health care consumers? What emerging methods to document competence should certification boards consider for the future? How is PNCB's Board of Directors making decisions about changes to Recert? In this **Stakeholder Summit on Continuing Competence**, we presented our process and findings. Attendees representing each credential, students, other certification boards, and our accrediting organization were asked to give us feedback on our proposed direction.

Our unique methodology incorporated ethnographic interviews throughout the health care landscape to understand the culture of competence. We also fielded multiple surveys, analyzed competency models throughout the U.S., and validated conceptual constructs with the aim of making recertification more meaningful for all involved. More than 12,000 certificants provided in-depth feedback about Recert possibilities and what they and employers valued for continuing competence activities. This holistic approach will translate evidence into a renewal process that resonates more deeply for every stakeholder.

- Our first change will be to transition the 3-year Pediatric Primary Care Mental Health Specialist (PMHS) renewal to annual.
- In the coming months, PNCB's Board of Directors will make additional decisions. The proposed changes for the future are:
 - a. Increase the value of Professional Practice Learning (PPL) from 5 credits to 10 credits. PPL includes activities like authorship, precepting, posters, lectures/presentations, committee work, and QI projects.
 - Add a new category to PPL: national and international awards.
 - Have CPNs quickly categorize their activities on the Recert application as one or more topic areas of the new Pediatric RN Competency Framework.
 - Conduct research to develop a CPNP-AC and CPNP-PC competency framework.
 - Change "Clinical Practice Hours" to simply "Practice Hours" and make it clearer that in-direct practice hours impacting pediatric nursing besides hands-on care will count.

Through the Continuing Competence Initiative, PNCB also unveiled:

1. **The Pediatric RN Competency Framework**, which describes the evolution of practice for all pediatric registered nurses and will support PNCB's Certified Pediatric Nurse (CPN) certification program. Definitions, exemplars, and behavioral indicators were validated for the competency areas of Clinician, Collaborator, Advocate, Educator, Leader, and Innovator.
2. **The Pediatric Nurse Mindset**, a statement describing essential tenets embodied by pediatric nursing professionals. Validated by more than 12,000 certificants in 2020, the Mindset explains that pediatric nurses are not simply nurses who work with children. What makes a pediatric nurse different from other nursing staff is that they represent the best resource to support optimal child health.

PNCB was represented at the National Organization for Nurse Practitioner Faculties and American Association of Colleges of Nursing Task Force for a 6th edition, Criteria for Evaluation of Nurse Practitioner Programs (National Task Force Criteria).

PNCB also represented nursing certification boards for a project through the [Society to Improve Diagnosis in Medicine](#) funded by the MACY Foundation. The goal was to create a paper and summarize recommendations for the 'next steps' needed to advance diagnosis education in health professions such as nursing / medicine / pharmacy (In press, *Diagnosis*, 2021).

Additionally, PNCB wrote a [letter to the editors](#) of the *Journal for Nurse Practitioners* regarding the article "Primary Care and Mental Health: Overview of Integrated Care Models." In our letter, we explained the value that Pediatric Primary Care Mental Health Specialists also bring to integrated care.

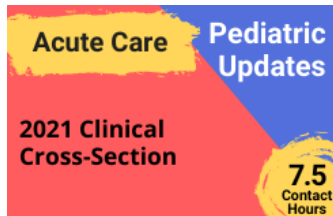

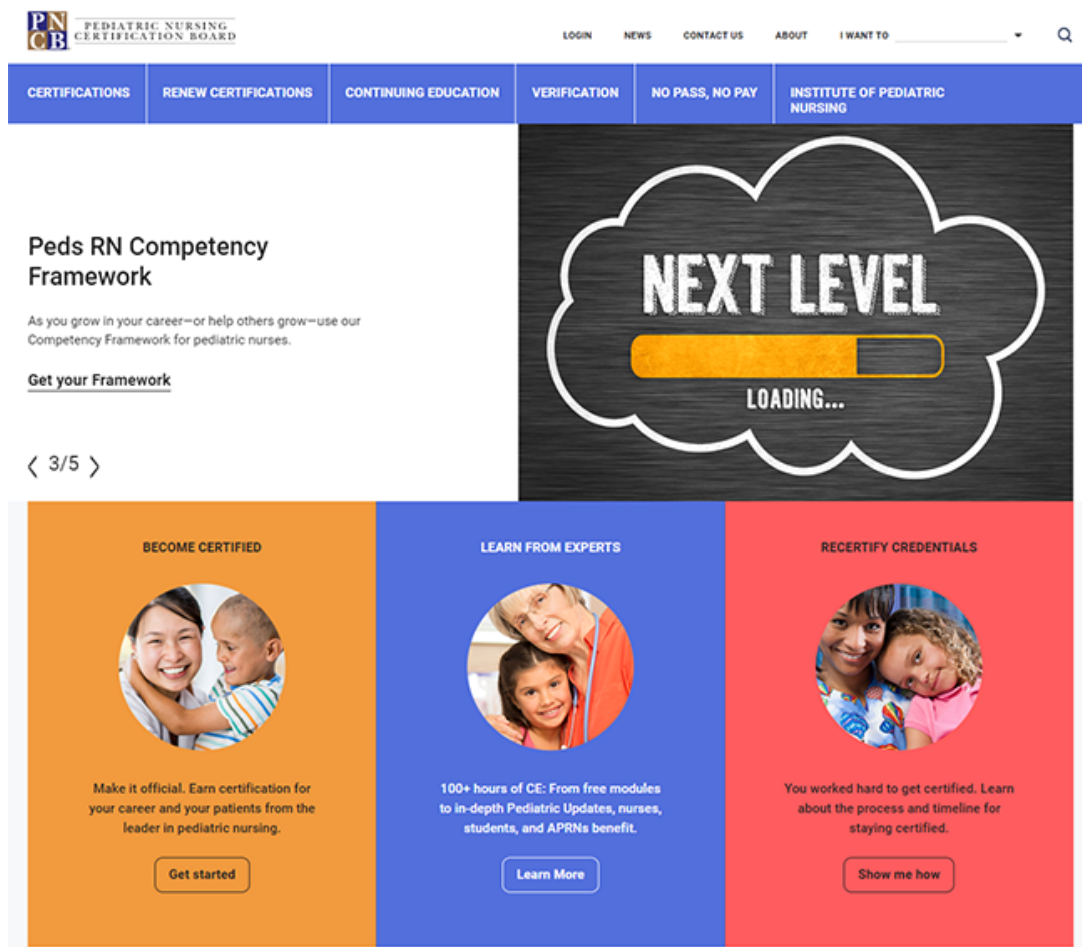

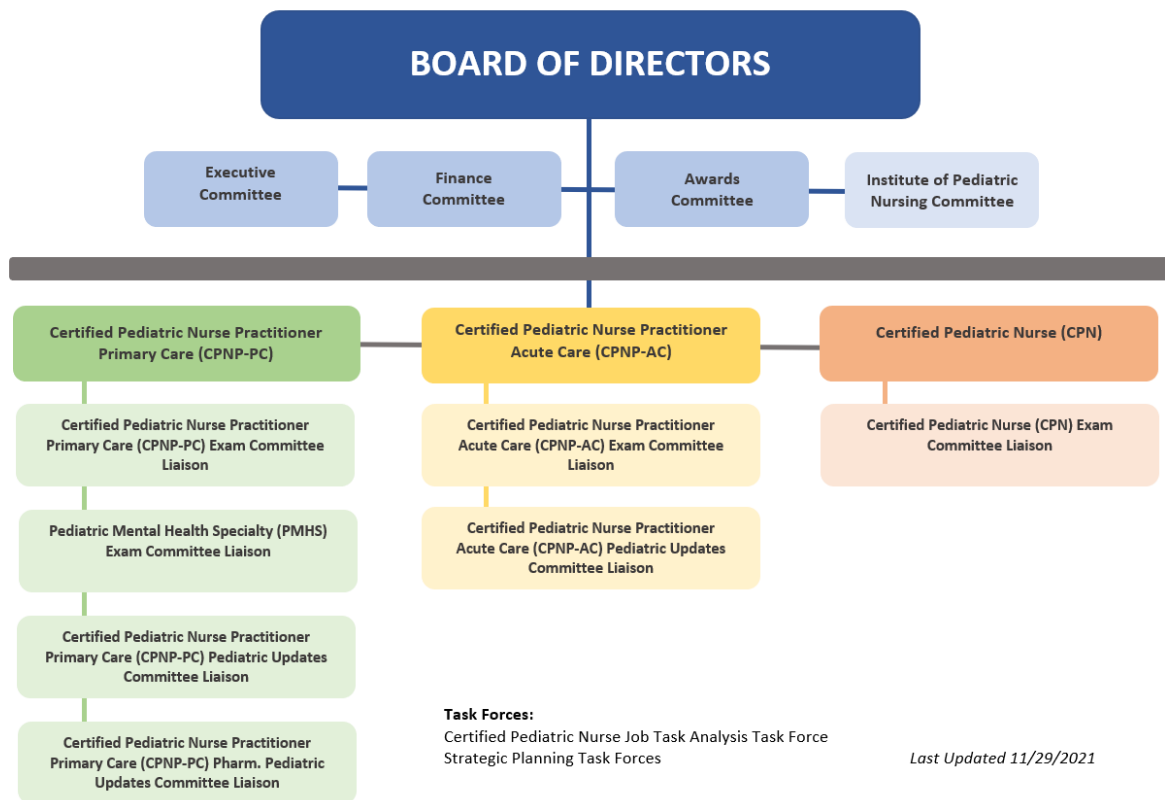
